CAMPSITE & STRUCTURE FORM

All forms must be returned.

The following guidelines will apply to your hunt license agreement. Please read the below bulleted items which may affect campsites or structures currently on your licensed property.

Structures which remain on the property year-round must be declared and paid for. Charges are \$200 per structure, plus a campsite fee (1 acre increments) annually.

- ◇ Campsites must be established in order to have any structure on the property, year-round or seasonal. If a campsite fee is not currently included in your license agreement, please contact us for approval, 980-430-6150.
- ◇ Campsites with existing utilities will be double the existing campsite rate.
- ◇ Structures (non-permanent) can remain on the licensed property, free of charge, from September 1-April 30. Any structures which will remain on the licensed property May-August, are assessed a \$200.00 fee per structure.
- ◇ All temporary structures must be removed by May 1st. Any un-declared structures which are left on the property beyond this time are the responsibility of the hunt club contact.
- ◇ All campsites are subject to inspection and audit by Molpus Woodlands Group. Any structures found on the property which have not been declared on this form and paid for will be billed to the hunt club at \$400.00 each.
- ◇ No permanent structures of any kind will be allowed.
- ◇ New utilities are not allowed under any circumstance.

Definition of a structure:

A Hunting Campsite is defined as an area designated by Licensor upon which one or more camp structures are to be located. Hunting Campsites may vary in size as designated by Licensor. Hunting Campsites are assigned to the hunting club Licensee and not to individual campers. All campers are expected to group together into designate Hunting Campsites.

Definition of a campsite:

Tents, existing mobile homes and trailers, if they have wheels, attached are allowed. Any wooden structure must be portable.
